#### 4.0 Scope of Work – The scope of work is not limited but includes:

## 4.1 Work to be done on daily basis.

- 1. Check for any abnormal noise/vibration from moving parts e.g compressors, motors, fans, sparks in the electricity board etc., In case of any abnormality, investigate & correct the same.
- 2. Check the incoming and outgoing load supply voltage.
- 3. The Electrician will maintain logbooks for recording the voltage in the morning and at peak office hours.

- 4. Check, maintain & replace electrical installations at Main LT panels, sub panels, DBs, etc. for complete office wherever required take corrective actions.
- 5. Current leakage to be checked and mended, if any.

#### 4.2 Work to be done on weekly basis.

- 1. Check & maintain the fire sprinklers and ensure its working.
- 2. Check & maintain the zone wise circuit of fire alarm system.
- 3. Check & maintain the hooter & other signaling systems.
- 4. Check & maintain any loose boults in the electrical systems.
- 5. General checking of electrical switchgears, controls, bus bars, load bearing wires etc.
- 6. Cleaning & maintenance of Electrical room, LT panels, DBs.
- 7. Take shutdowns for regular maintenance, if required.
- 8. Check the LeD lights, fans, chokes and replace the non-working.
- 9. Maintain close coordination with the NSIC fire team.
- 10. Check the LeD lights, fans, chokes and repair wherever feasible.
- 11. Inspect the electrical control panel and starters to see that all power/control contacts are clean, all terminations are sound and all fuses are intact.
- 12. Record all the major events in the register.

## 4.3 Work to be done on monthly basis.

- 1. Performance check of the hooters shall be done along with the performance check of manual call points.
- 2. Check fault circuit of each zone by actually disconnecting wire by removing a detector.
- 3. Check fire circuits by facilitating actual smoke to one detector of each zone and Cleaning of all types of detectors with suitable means.
- 4. Overall servicing of the unit, cleaning, reduction of noise level.
- 5. Check for any leakage in the HVAC Ducts and repair, maintain, replace them, wherever & whenever required.

## 4.4 Deployment of trained & qualified Electrician

Deployment of one full time trained electrician in BIRAC Office from 08:30 am to 6:00 pm (Monday to Saturday) to maintain all day-to-day electrical issues including maintenance, replacement and upkeep.

## 4.8 Tools & Plants

All the general & special tools, tackles including chain pulley blocks etc., required for proper maintenance and repairs and attending break down etc, shall be arranged by the contractor at his own cost and issued to the staff deployed by him for this work.

# 4.9 Consumables

The rates shall be all inclusive of establishment as well as spares and consumables as per scope of work. The bidder is required to assess the probable quantity of all types of spares and consumables likely to be required for replacement for keeping all the installations in good working conditions and include the lump sum cost of these spares & consumables. Nothing extra on any account shall be payable over and above the approved all-inclusive comprehensive rates of the contract. The consumables and spares shall be of best standard quality purchased from the original manufactures or authorized dealers only. All spares and consumables shall be arranged by the contractor for which nothing extra shall be payable. Replaced parts/ spares, used burnt oil etc. will be property of the vendor.

It is his responsibility to disposed them off immediately as per norms of Pollution Control Board. All the maintenance woks shall be carried out in accordance with the manufacturer's specification and instruction. However tentative schedule of maintenance shall be as per the format given.

#### 4.10 Penalty clause:

The corrective/breakdown maintenance is to be carried out any time during 24hrsX 365days.

a) Minor and Major Maintenance: - Inclusive of Repairing and Replacement of all Spares/Components and all other associated accessories which are covered otherwise and attention of all defects other than major defects.

Resolution Time for Minor Maintenance (Within 24 Hours Maximum)

Resolution Time for Major Maintenance (Within 72 Hours Maximum)

If work is not done as per above schedule or any system is not functioning then a penalty @ rate of Rs. 500/- per day shall be imposed on contractor for each location separately and will be deducted from the AMC amount due to the contractor and if unsatisfactory performance is continued for more than two days, the AMC is liable to be terminated and final decision for this shall rest with the BIRAC.

If contractor is not able to rectify the fault beyond above schedule. Then the same may be got done through some other agency at the risk and cost of contractor failing which the same amount will be deducted from AMC bill and penalty as stipulated above will also be imposed. However, the decision of the BIRAC in this regard shall be final and binding.

# Deployment of Site Supervisor and Technician/s in BIRAC to ensure smooth functioning of HVAC systems, Electrical system and Fire system.

Mere deployment of MAN POWER does not amount to fulfilment of obligation of the contractor. Contractor will be responsible for satisfactory maintenance of all the systems under the **scope of contract** and smooth functioning of all services in the BIRAC, New Delhi.

The contractor shall depute full time technicians / mechanics, who have undergone the basic training of all the tools / equipment to handle any emergencies with regard to all-inclusive comprehensive maintenance of HVAC systems, Electrical system and Fire system.

At the time of deploying manpower, the Contractor shall strictly comply all the applicable labour laws /Acts norms including but not restricted to the age of the workers, women workers and shall also ensure that a police verification and security check for all the workmen engaged at the BIRAC's premises is done.

The contractor shall issue the identity cards to his Supervisor/Technician/s on his own cost and shall intimate to BIRAC in writing as and when there is any change. The Contractor should provide 2 sets of uniforms of approved colour for the employees deputed in BIRAC at their own cost and also safety shoes one pair should be provided to each employee. The contractor shall ensure to provide an alternate qualified manpower or replace with a stand by in case any of the deployed staff is absent or on leave. The contractor shall ensure that the workmen deployed by him behave decently and do not indulge themselves in any such activities, which are unbecoming on the part of a person working in the Government Office.

Daily working hours for **Technician/s** shall be 09:00 hours in a day with 30 minutes break for refreshment. Contractor shall be available to attend the call any time. However, in exceptional circumstances, BIRAC may require the Contractor to undertake the work even on Sundays or government holidays or at such other times and hours as shall be necessary and requisite and the Contractor shall be bound to mobilise adequate number of Supervisor/ Technician/s for completing such work in the manner required by BIRAC.

During break down, if required more skilled/un-skilled workers may be deployed in BIRAC by the contractor to complete the work without interruption of services.

The contractors shall be responsible for the safety of all the items of furniture, plants, office equipment and other fittings provided in the premises and shall be liable to make good any loss to the same if damaged during the execution of their duties which shall be recoverable from their monthly bill or other dues payable to the contractors by the company.

The contractor shall be responsible for the good conduct and behaviour of his employees. If any employee of the contractor is found misbehaving with BIRAC staff, the contractor shall terminate the services of such employees at their own risk and responsibility. The contractor shall issue necessary instruction to his/its employees to act upon the instructions given by BIRAC.

The contractor shall be available to attend the call all times over phone for receiving instructions from the BIRAC. The Contractor shall attend all site meetings with their Supervisor & co-ordination meetings & arrange to carry out work smoothly as per the agreed time schedule. Any instruction given to the site supervisor shall be construed as if the same is given to the contractor.

In case of break down immediate action must be taken to rectify the fault and restore the functioning of systems within reasonable time as considered by BIRAC failing which penalty clause will be invoked. The contactor is also expected to maintain a minimum Inventory of critical spares that have long delivery period.

Any material required for making good the damages will be brought by the contractor at his own cost and risk, and such material should be of proper brand and of good quality.

The firm will be responsible for the security/insurance of their staff working at site and BIRAC will not be responsible in any manner in case of any accident / miss- happenings.

They shall be responsible for any periodic statutory inspection to be carried out on the equipment necessary test report and certificate rectification of defects, pointed during such inspection etc.

Contractors should follow all safety norms and provide necessary safety equipment at their own cost. In case of any accident during the testing / maintenance of the equipment leading to injuries / damages to human beings' equipment and / or loss of life, the contractor shall be fully responsible for setting all claims and indemnify the department against any claims arising out of such accidents. Consequent damages to other systems will however be recoverable from the contractor.

#### 4.11 Watch & Ward

Watch and Ward of their material, machineries and system etc. till end of the contract shall be the sole responsibility of the contractor and pilferage etc. shall be entirely to his account and will be handed over to client in good working condition at the termination of contract.

# 5.0 Instructions to Bidders

- 5.1 The bidders are expected to examine all the instructions in the Bid Document. Failure to furnish all information required by the Bid Document or submission of a Bid not substantially responsive to the Bid Document up to the satisfaction of the BIRAC in every respect will be at Bidders' risk and responsibility and may result in the rejection of its Bids.
- 5.2 Any agency who has pre-exited or terminated any contract with or by BIRAC in last five (05) years as on the date of submission shall not be eligible to apply.

# 5.3 Language of Bid

The bid prepared by the bidders and all correspondence and documents exchanged between the bidders and BIRAC relating to the Bid submitted shall be in English or bilingual (Hindi and English) language. However, printed literature furnished by the bidders may be in any other language as long as it is accompanied by an English translation of all its contents. In such a case for the purposes of the interpretation of bid, English translation shall prevail.

## 5.4 Signing the Bid

The bid shall be signed by the bidders or a person duly authorized to bind the bidders to the contract. The authorization shall be indicated by written letter of authorization/ agency agreement etc. accompanying the bid. The person or persons signing the bid documents shall initial all pages of the bid, except for un-amended printed literature.

## 5.5 Cost of Bidding

The bidders shall be solely liable to bear all costs and expenses associated with the preparation and submission of its bid, BIRAC will in no case be held responsible or liable for payment of any costs associated with the preparation or submission of the said bids irrespective of the outcome of the bidding process as also in case the entire bidding process or part thereof is nullified/ cancelled due to any reason whatsoever.

## 5.6 Validity of Bids

- i) Bids shall remain valid for 90 days after the bid closing date. A bid valid for a shorter period will be considered as non-responsive and be liable to be rejected by the BIRAC.
- ii) In exceptional circumstances, BIRAC may solicit the bidders' consent to an extension of the period of validity.

## 5.7 Submission Details

Bidders are requested to go through all pre-qualification requirements, scope of work for execution & requirements w.r.t technical / financial capabilities for acceptance and submission of documents for verification by BIRAC. Bids are to be submitted in sealed covers.

#### 5.9 Special Considerations For MSME/Start-Ups

If the bidding entity is registered under (i) Micro & Small Enterprises at District Industry centre or Khadi and Village Industry Board or Coir Board or National Small Industry Corporation or Directorate of Handicrafts and Handlooms or any other body specified under "Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012" & (ii) Start-Ups registered under DIPP (as per G.S.R. 501(E)) it will be exempted from the prior experience & financial criteria.

The participating Bidders who qualify any of the above aspect shall be allowed L1+15%margin of purchase preference in the Price Bid for the purpose of evaluation. After giving such margin, if more than one Bidder stands on equal Price Quote, then the Bidder having more relevant experience can be considered for award of contract.

# 5.10 Amendments and Addendum to Bid

- i) At any time prior to the deadline for submission of bids, BIRAC may at its own discretion and for any reason whatsoever whether at its own initiative or in response to a clarification requested by a bidders modify the Bid Documents by notifying any such amendment as may be drafted/incorporated to the original bid documents.
- ii) The amendment and addendum, if any will be notified by BIRAC or published on the BIRAC website (<u>www.birac.nic.in</u>) before the last date of submission.
- iii) In order to allow the bidders reasonable time to take the amendment in to account in preparing their bids, the BIRAC may at its discretion, extend the deadline for the submission of Bids and any such extension will be notified by BIRAC.

## 5.11 Conflict of Interest

The Bidders shall not receive any remuneration in connection with the assignment except as provided in the "Service and Confidentiality Agreement".

#### 5.12 Warranty of the agency

The agency shall warrant that it is under no contractual restrictions of legal disqualification or other obligations which will prohibit from entering into agreement and that the statement and particulars herein contained in this Bid and in the relevant and supporting documents to this Bid are correct.

## 5.13 Bid Rejection Criteria (BRC)

BIRAC reserves the right to reject any bid if:

- 1. Received after the expiry of due date and time.
- 2. Any agency who has pre-exited or terminated any contract with or by BIRAC in last five (05) years as on the date of submission shall not be eligible to apply.
- 3. It is not given in the prescribed format as per clause 5.7
- 4. The bid has not been indexed or properly paginated and details provided in PQC Checklist (clause 7.0) are not submitted.
- 5. Supporting documents to substantiate the PQC have not been submitted.
- 6. Certificates certified by Chartered Accountants must bear UDIN number, in absence of which, it will be considered as invalid and the bid shall be rejected.
- 7. All Declarations/undertakings/information have not been provided on the Letter Head of the Bidders, duly signed and stamped.
- 8. At any time, a material misrepresentation is made or uncovered
- 9. The agency/ firm/entity does not respond promptly and thoroughly to requests for supplemental information required for the evaluation of the bid.

#### 5.14 Engagement Terms and Conditions

- i) The effective date of the engagement will be in accordance with execution of the Service and Confidentiality (S&C) Agreement.

## 5.16 Disclaimer

- a. BIRAC shall not be responsible for any late receipt of applications for any reasons whatsoever.
- b. BIRAC reserves the right to reject all applications without assigning any reasons thereof.
- c. To relax or waive any of the conditions stipulated in this document as deemed necessary in the best interest of the BIRAC without assigning any reasons thereof.
- d. To include any other item in the Scope of work at any time after consultation with bidders or otherwise.
- e. BIRAC reserves the right to reject all the RFPs without assigning any reasons.

# 5.17 Jurisdictions

All the disputes or difference differences regarding the bid/contract shall be governed in accordance with the Laws applicable in India and subject to by the exclusive jurisdiction of the courts situated at in New Delhi, India.

# 5.18 Earnest Money Deposit (EMD)

- <u>Submission of EMD</u>: The Earnest Money @1% of the estimates annual cost of contract in the form of a Demand Draft, payable at New Delhi from any commercial bank in favour of "Biotechnology Industry Research Assistance Council" (BIRAC) has to be submitted along with bid document. If the bid is received without EMD, it will not be considered and will be summarily rejected.

## 3. Terms of Engagement

- iv. BIRAC will not retain any control for direct supervision of the contracted services and execution of this Contract does not create any liability, explicit or implicit, on BIRAC in respect of the manpower engaged.
- v. This may be executed in two or more counterparts, each of which shall constitute an original and all of which shall be deemed a single Contract. However, the same shall be done after prior written approval of BIRAC.
- vi. The rights and remedies herein provided are cumulative with, and not exclusive of, any rights or remedies provided by law.
- vii. The Agency shall be entitled to the fees and reimbursement for all preapproved expenses incurred in the performance of the Duties, upon submission and approval of written statements and/or receipts in accordance with the then regular procedures of the BIRAC.
- viii. BIRAC reserves the right to assign the tasks to any of the agency. BIRAC also reserves the right to award the work to any other agency, not necessarily with BIRAC.
  - ix. This does not constitute and will not be deemed to constitute an exclusive commitment/ arrangement between BIRAC and the Agency.

#### 4. Responsibilities of the Agency

- iii. Deploy any workforce which will exclusively be on Agency's pay roll.
- iv. Ensure proper behavior of the work force provided for the event. The Agency will prevent the work force from taking part in any direct or indirect association with a person or persons engaged in any antisocial activities, demonstrations, riots of agitation, which may in any way be detrimental or prejudicial to the occupants of land / properties in the neighborhood.
- v. Keep the BIRAC and its employees etc., harmless and indemnified from any consequential claims, actions, suits, proceedings, losses or damages on any ground whatsoever.
